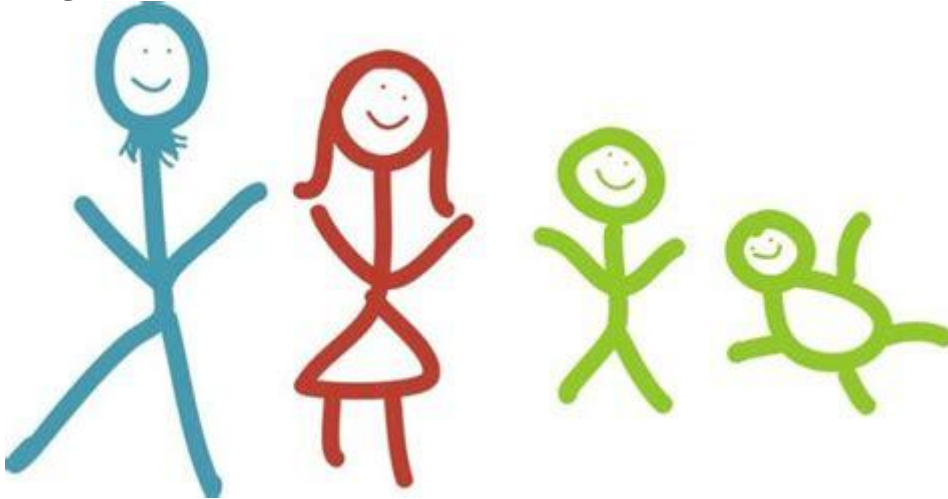


Reducing Parental Conflict in Bristol
